Minutes

Item	Topic	Conclusions/Discussions	
1	April BOG meeting minutes	Minutes was already circulated for approval.	
2	Convention update	Bimal Mishra updated on convention. Roughly around 40 artists are coming from Odisha. He mentioned that around 400 families have registered and we are expecting around 500 registration. He showed his concern about budget. He mentioned that \$105,000 already in red. He asked for suggestion if loss happens. Members suggested to cut programs, spend according to the budget and loss should not be in our mind.	
3	OSA Election Result	Tapan updated that BOG members have approved the election result electronically. The Addendum on BOG approval is included at the bottom of the minutes. The special newsletter will be published soon that will go to members. He also mentioned that we will start a new precedence that from July 5 the new officials will take over. Prashanta Ranabijuli mentioned that he has already sent the transition list to the new elected treasurer.	
4	Convention guideline approval and sponsorship agreement	Sikhanda mentioned that he had already sent for approval and it was approved. He thanked to those who had gave feedback. He stated that we have started sponsorship signed agreement which would be added to award guideline. He also mentioned that Sitakantha Dash has agreed to donate \$100,000 to OSA over a period of 10 years. Each year OSA will receive \$10,000 from his foundation. Members appreciated Sitakantha Das's generosity. Annapurna Pandey asked when was the convention guideline approved. Sikhanda mentioned that it was approved as per by-law VIII (See Appendix 1). He also mentioned that convention guideline is a living document. So, if anyone has any more proposition, he can send the suggestion for next update and approval. He also requested everyone to participate actively to read the guidelines and provide feedback. Members also discussed about RDF. Sikhanda reminded that as RDF is not in agenda item, we need to focus on the agreed items only.	



Item	Topic	Conclusions/Discussions
5	Ohio convention membership issue	Prashanta mentioned that finally we received the report from Ohio and we found out that 63 are non-members. The draft list was sent on 12 th of April and final list was sent on 5 th of May. He emphasized that we need to close up this topic and cover the loss of revenue from convention money. Members discussed on this issue. They also discussed that instead of finger pointing anybody, it is the loss of revenue for everyone. Ultimately, OSA will have to pay half of it and chapter will pay half of it. Anil Patnaik mentioned that OSA national knew that membership fee was not collected. Sikhanda reminded that there were several communication were done to convention committee including convener and chapter president. But convention committee didn't communicate the details of nonmembers. Sabita also emphasized that OSA national had been trying to get the number with details but could never get it from convention committee. Anil mentioned that guideline should mention about collecting membership. Sikhanda reminded that it is already in the guideline that membership fee should be collected from convention attendees. Convention convener and convention treasurer didn't send any report to show who paid and who didn't pay the membership fee. Rather convention treasurer always verbally mentioned that there were only 10/15 attendees who didn't pay membership fee. Anil emphasized that convention guideline should be made robust about collecting membership so that such errors are never repeated again. Sabita appreciated Anil's effort to provide the report from which BOG members could get the information that 63 nonmembers didn't pay the membership fee. Sikhanda mentioned that convention team should have given this report. Sikhanda and Prashant appreciated Anil's effort. Prashanta will send the proposition electronically for approval.
6	India Bank account	Tapan Padhi mentioned till today OSA had used a personal account. He updated that OSA got a PAN card which was a requirement to open an account in India. He updated that it is
