#### Introduction

Along with helping the 2024 convention committee, this committee will also work to streamline a few convention processes and simplify a few convention tasks for the future..

The President informed us that after the website transition we see some issues with the current membership database - and the team is currently working to resolve those issues. When necessary the team will reach out to the BOG officials to validate information.

#### **Committee Introduction**

Advisory committee

Due to some issues, all these committee members couldn't make it possible to join. Though we missed a few members, two of our committee members joined the call. They contributed their valuable insights on few of the current processes. The EC team has maintained a strong connection with them throughout and has consistently sought their advice when facing various situations. Both the advisory members appreciate the effort of making single-channel communication.

#### **Grievance Committee**

Legal Counsels -

Both team members joined the call and introduced themselves to the team. The President advised the BOG team to contact Legal counsels if they have any questions and also announced that a Constitution Review committee will be established soon to collaborate with the legal counsels. This initiative is in response to the fact that more than 10 years have passed since the last review.

## PRO (Public Relation Office) Team

All the three team members joined the call and introduced them to the BOG team. The goal of the team is to establish a single communication point for the organization.

#### Round Table

The President provided the BOG team with an overview of ongoing tasks across various fronts, including website development, membership database validation, OSA's hosting resources, the establishment of the 2024 convention website, meetings with committees to finalize closure reports, and the request for a committee roadmap outlining plans for the next two years.

The team discussed a few miscellaneous issues at the chapter level and realized a need for more communication for the team members. It was decided that an informal optional gathering would take place later this month to gain a better understanding of routine operations and to brainstorm ideas for addressing any existing gaps.
