## Proposal 3: Annual Convention Seed Money increase from 10k to 25k

## **Description:**

This proposal is to increase the seed money for the annual convention from 10k to 25k. This will be applicable for the 2025 Convention onwards.

## Justification:

For the past few years, every convention team has come up with a reason to get additional amounts which takes time to complete the process on multiple fronts. We also see that the cost of everything has gone up. Considering the increased cost of everything today, we propose to increase the seed money for the convention.

## Impact:

Once it is approved Convention guidelines need to be updated to reflect the amount.

# **Constitution Amendment**

## Proposal 4: By Law - II /Section 3 – Convention Finances

If the convention account is not closed by November 30th of the convention year, the Convention team shall be liable to pay an additional fee amounting to 2% of the convention's total revenue or budget.

## **Description:**

In the event of not closing the convention account by November 30th of the convention year, the Convention team will be liable to pay an additional fee equal to 2% of the total revenue or budget of the convention.

#### Justification:

There has recently been a trend of convention accounts not being closed on time, leading to insufficient time for audits and delayed tax filings. Adding this clause to the account closing process may encourage the convention team to close accounts promptly.

## **Discussion:**

This was discussed earlier briefly however it was brought to the floor for discussion again. Though everyone agreed on this proposal, some of them suggested reducing the amount or making it a fixed amount. To which, there was a conscious decision to keep the amount on the total budget of the convention since every convention has a different budget. Some members suggested reducing the amount to which everyone agreed that the goal is not to make any convention pay this amount, but to encourage timely account closing - so a little bit higher no is better. After discussion, we all agreed, reducing the amount would not address the underlying issue, and the problem would likely continue.

#### Proposal 5: Article V (Elected Officers & the Executive Committee)

#### Avoid conflict in OSA Executive Leadership position-

Elected Officers must confirm that they do not hold any such executive or similar leadership position in any other nonprofit organizations during their term. At the time of their nomination each candidate for the role of an Elected Officer must confirm that if elected, they will resign from any such position. Determinations of whether a position constitutes an "executive or similar leadership position" shall be made by the Elected Officers in their sole discretion.

**Description:** This will be applicable to all 4 OSA EC positions. President, Vice President, Secretary & Treasurer.

**Justification:** This will help OSA executives to focus on the organization during their tenure without dividing their attention. In addition it will prevent potential future conflicts in Odia, ODisha in relation to OSA.

#### **Discussion:**

Even though this proposal was initiated in past few meetings President Leena Mishra opened a discussion on this proposal. She mentioned that OSA National leadership positions require a significant time commitment in order to do justice to these positions. She highlighted that all elected officials are volunteers who manage these roles alongside family, work,home, and social responsibilities. The leadership positions demand undivided attention over the two-year term to bring a little change. In addition, she also pointed out that the organization has grown significantly and requires good governance practices to function smoothly - hence there is a necessity to be proactive and avoid potential conflicts of interest in these roles.

Bhabani Buxi, President of the Georgia chapter, and several others supported the proposal wholeheartedly. Satyabrata Mohanty, President of the California chapter, inquired whether this restriction would apply to chapter leaders as well - to which President Leena Mishra clarified that the restriction currently applies only to the four OSA EC officers and not to chapter leaders.
